

HİTİT BİLGİSAYAR HİZMETLERİ ANONİM ŞİRKETİ COOKIE PRIVACY NOTICE

As Hitit Bilgisayar Hizmetleri Anonim Şirketi (“Hitit”, “Site Owner”) we are working to protect the privacy of our members who use our website in order to provide the secure and complete operation of our website. As such, this Cookie Privacy Notice has been prepared by Hitit, in its capacity as data controller to process personal data of our members in compliance with Article 10 of Law No. 6698 on Protection of Personal Data (“the Law”) and the Communiqué on Procedures and Principles in Fulfilling the Obligation to Inform.

Hitit uses Cookies in order to provide an information society service to its members/visitors/users (together will be referred to as “Data Subjects”); to authenticate visitors to the Site to ensure that the Site and services provided by Hitit are secure, and to perform analytical functions through the domain name <https://hitit.com/> (“Site”) that is operated by Hitit.

This Cookie Privacy Notice has been prepared to inform the Data Subjects related to Cookies clarify the purpose of Cookies used on the Website and to explain to Data Subjects how to manage their Cookie Settings. You may manage your Cookie Preferences via our “Cookie Preferences Settings” or through your browser.

What are “Cookies”?

Cookies are simple text files that are placed on Data Subjects’ devices by website operators that permit certain information on Data Subject to be stored on terminal devices upon visitation of the website.

Supporting software may be needed to facilitate Data Subjects’ use of certain sections of the Site. If such sections of the Site are used, data on manner and scope of such use may be stored on Site’s database.

Cookies are used to make Data Subject’s use of the Site easier and to provide Hitit with non-personal, statistical, performance and analytical data on the use of the Site.

What are the types of “Cookies”?

Cookies are categorized according to their duration of use, purpose and parties.

(i) Cookies Based on the Duration of Their Use

Session cookies permit storing of actions during a single browsing session and are deleted once the session expires.

Permanent Cookies stay on your device in between sessions and allow for users to be “recognized” and their preferences to be remembered. These cookies will stay on your device unless they are deleted or until their expiry date.

(ii) Your Personal Data Collected

Within the scope of conducting Hitit’s activities, your personal data specified below may be processed.

(iii) Cookies Based on Their Purpose of Use and Legal Grounds

Absolutely Necessary Cookies (Mandatory Cookies) are those that are required for the functioning of the website. Such cookies are used to provide essential services of being a part “information society” (logging-in, filling in forms, remembering of privacy settings.)

Disabling necessary cookies will cause certain sections of the website to not work properly. For the data processing activities that we carry out during the use of these cookies, we rely on the legal ground of **“processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract”** within the scope of Article 5 of the Law.

Functional Cookies are used for remembering personalization settings and preferences on the website or applications. These cookies are used to operate functions other than those operated by “absolutely necessary cookies.” For the data processing activities that we carry out during the use of cookies when you explicitly request the relevant information society service to record the preferences that you have made and accordingly, personalize the Website for you, we rely on the legal grounds of **“processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract”** and **“processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject”** within the scope of Article 5 of the Law.

For the data processing activities that we carry out during the use of cookies in cases where you do not explicitly request the relevant information society service, and during the use of third-party analytics cookies we rely on your **“explicit consent”** within the scope of Article 5 of the Law.

Performance-Analytical Cookies These cookies permit statistical measurement by analyzing users behavior on the Site. These cookies are used to improve the Site and measuring the effect of advertisements on users is included in such use. For the data processing activities that we carry out during the use of cookies when you explicitly request the relevant information society service and during the use of first-party analytics cookies, which are used for the purposes that do not significantly affect the privacy of the users, such as obtaining general – statistical information and are statistical measurement tools, we rely on the legal grounds of **“processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract”** and **“processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject”** within the scope of Article 5 of the Law.

For the data processing activities that we carry out during the use of cookies in cases where you do not explicitly request the relevant information society service, and during the use of third-party analytics cookies we rely on your “**explicit consent**” within the scope of Article 5 of the Law.

Advertising or Targeting Cookies are used to track users' online activities in order to identify their personal interests and display advertisements tailored to those interests in the online environment. For the data processing activities, we carry out during the use of these cookies, we rely on your “**explicit consent**” within the scope of Article 5 of the Law.

(iv) Cookies According to their Parties

First party cookies, are those that are placed directly by the Site. (<https://hitit.com/>).

Third party cookies may be placed by the website that the user has visited from or by the third party that operates the software used to support the functioning of the Site (i.e. Google Analytics or Yandex Metrics).

How can you disable Cookies?

You may adjust your cookie preferences through your browser settings to adjust your preferences for all websites you will visit in the future or through “Cookie Preferences Panel” for Hitit’s Site in particular.

How and based on what legal grounds do we use cookies?

We use cookies for the following purposes and legal reasons:

Necessary Cookies – These are mandatory cookies for the correct functioning of our website and to provide the information society service that the Data Subject requests. We use these cookies to authenticate identity and to save information about your current session. These cookies are not used for any advertising/marketing purpose.

Performance and Analytical Cookies – These cookies are used to improve our website. We use these cookies to determine user behavior, likes, and to analyze preferences by creating statistical data. These cookies collect information on Data Subjects’ use of the Site and are used to audit the correct functioning of the website and for determination of errors.

Functional Cookies – These cookies provide us opportunity to remember preferences of Data Subjects that visit our Site. For instance, the Site may remember language preferences or cookie consent settings. Some of these cookies are essential for the functioning of the Site, and not permitting their use may result in a certain customization to not function properly or your preferences to not be remembered.

Google Analytics and Yandex Metrics Cookies – These are third party cookies which may be necessary, performance and analytical and/or advertising/marketing cookies to support Google Analytics and Yandex Metrics softwares we use to operate our Site. Social Add-on Content Sharing

We may place images, videos or other content from third party websites within the Site. As a result, when you visit these websites that host such content, you may encounter cookies from such sites. If you have already logged in to the relevant social network on your browser and if the cookie of the Data Subject is absolutely necessary for the functioning of such add-on, your personal data may be processed without explicit consent. However, if you have logged out from such social network or if you do not have a membership, your personal data may be processed with explicit consent.

To Whom Do We Transfer Your Personal Data?

Your personal data may be transferred within the scope of the data processing conditions set out in Article 5 of the Law, in compliance with the rules regarding the transfer of personal data specified in Article 8 of the Law.

What are the Rights of the Data Subject?

If as the data subject, you submit your requests regarding your rights listed under article 11 of the Law to our Company by the methods set out below, our Company will finalize the request free of charge as soon as possible and within thirty days at the latest, depending on its nature. However, if the transaction also requires a cost, the fee in the tariff determined by the Personal Data Protection Board will be charged by our Company. In this context, in accordance with paragraph 1 of Article 13 of Law, you may submit your request to exercise your rights mentioned above to our Company in writing or by other methods to be determined by the Personal Data Protection Board in the future. In this context, the channels and procedures you will submit your written application to our Company within the scope of Article 11 of Law are explained below.

In order to exercise your rights mentioned above, you may submit a wet signed copy of the Data Subject Application Form, a sample of which is available at <https://hitit.com/themes/hitit/documents/2026-02/ilgili-kisi-basvuru-formu.pdf> to "Hitit Bilgisayar Hizmetleri A.Ş. No:4/1 Arı Teknokent 2 Inner Door No:601 Maslak 34469 Sarıyer İstanbul" address via notary public, or in writing, by using the registered electronic mail (KEP) address, secure electronic signature, mobile signature or the electronic mail address previously notified to the data controller by the data subject and registered in the system of the data controller and you can send it to Hitit.
